

SDG AND PRESENT SITUATION

It is highly important to discuss about SDG at this time of great danger of the whole world. I am not in a position to discuss about this matter as little do I know, yet I want to share with you my feelings which have touched my heart. 193 countries of the whole world with their united power have endeavoured to fulfill the 17 objectives in 2030, which they have not been able to in the past. I do not know much of these objectives be successfully completed, but it is an undeniable fact that though the pandemic Covid-19 situation has made us face a number of grave problems, it has shown us the path of fulfilling some goals.

The ways of solving problems have been obviously indicated. The feelings that I am going to express will be identical with some of these 17 objectives of SDG. In this waveless flow of life, a wonderfulchange in the behaviour of Nautre was seen. We noticed some unknown birds singing in nearby trees, and in the social media we found peacocks and peahens moving in Rajpath of Delhi. The river Yamuna, whose pollution had gone beyond limit, was becoming clear gradually, the white darkness of smog and particles no more shrouded the Capital city of India. The unbearable heat-wave that swept through out the months of April and May, in Purulia, and people could not come out of home and without AC sleep at night was unthinkable, had been reduced to normalcy. In reality, the 13th objective of the SDG is being fulfilled.

A number of schemes, and missions had already been taken to bring all children of age group from 6 to 14, and to reduce drops out, but none of those missions were effective enough to fulfill the goal. Now it is time to bring education to the courtyard of very children, instead of bringing all the children to the field of education. Situation Covid-19 probably points to this direction. At present each and every educational institution is trying to reach the students through 'online class-teaching, YouTube and other social media. Let us think how education can be brought to the home of the learners. We have to find a way out, in which a learner can be provided allsorts' education ensuring all round development, Just as electricity has reached the remotest villages of India. Those who work in the field with their parents, or help their father in shop, will learn from home at night. There will be no question of drop out. Let schools and colleges be in Evening session. Learners are required to come to Institution only for the purpose of research work and orientation.

My findings are that if the wealthy and highly affluent people can restrain their aggressive life disciplined themselves in a tranquil and simple life and proceed towards liberalism, we would be able to achieve 117 objectives, not the 17 only, as mentioned in SDG.
