Article 14 states that State shall not deny to any person equality before the law. Article 15 ensure that there should be no discrimination on grounds of religion, race, caste, sex. Article 17 prohibits the practices of untouchability.



Though the articles contained in the constitution meant for the equality for all and non – discrimination on the grounds of sex, women is always discriminated and dishonored in Indian society. Although various efforts have been taken to improve the status of women in India, the constitutional dream of gender equality is still very miles away from becoming a reality. Article 42, directed to provide maternity relief to female workers. Over the years Indian Parliament have taken significant steps for through legislations to achieve the goal of empowering the women in India. Government in India has enacted a variety of laws like Dowry Prohibition Act, Sati prevention Act and many more to guarantee the rights of the women.

Basically there is a need to discuss the rights of the women separately because women counter parts represents more than half the population of India, then also yet she is discriminated and violated in every grounds of her life.

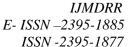
Violation of Women Human Rights In Ancient Time

The following crimes were done against the women in the past times:

- 1. SATI: Sati is an old custom in Indian society in which widows were immolated alive on her husband's funeral pyre. In pre colonial India, it was banned by Raja, but this practice continued to prevail in post colonial India.
- 2. PURDAH: It bounds their right to interact and to move freely in the society and it is a symbol of the subordination of women. Women were bound to follow this system very seriously.
- 3. DEVADASIS: Devadasis was a religious practice in some parts of southern India, in which women were married to a deity or temple. Basically women were forcefully bound to do this practices.
- 4. EARLY MARRIAGE: Again one of the most crucial form of violation of women's human rights which mostly took by the decisions of the elders of the family. As a result was that it basically hampers the life of small girls by making small girls child widow.
- 5. FEMALE INFANTICIDE: Another evil which in another way violates the women's human rights in one of the most brutal form. In colonial era, the practice was prevalent in many of the provinces. With the Act of 1870 Prohibition on female infanticide, not much was attained.

Violation Of Human Rights In Present Time

Violation of Right to Equality: The World Human Rights Conference in Vienna first recognized gender – based violence as a human rights violation in 1993. The same was declared by United Nations Declaration in 1993. Basically women subjected to different kinds of discrimination on several grounds. They do not possess equality in society as men do. A woman even today was considered as unwanted child in the family.





- 2. Violation of Right To Education: Education is one of the means to become empower for any individuals of the society. Education can bring a new light of hope in anybody's life. Education act as milestone in terms of any individuals then also women were deprived from this right. They can be only using their different laws in their defense when only they are educated. Then only this can be fruitful to their life. Due to the less percentage of uneducated women in India, are deprived from their fundamental rights and would never fight for them.
- 3. Violation of Right To Property: Generally in most of the Indian families, women do not possessed equal amount of property on their own names and do not get share of parental property. Most of the women had very less or no right over the parental property due to which they had to face harassment after their married life also.
- 4. Violation of Right To Live With Dignity: Sexual harassment of different kinds is an act of terror that violates a woman's body, life and also self respect. It is one of the terrific way through which a woman is systematically made to feel inferior, weak and afraid. Due to which they do not feel free to move in this cruel society. Thus, eve teasing denies a woman's fundamental right to move freely and carry herself with dignity.
- 5. Domestic violence, rape, child marriage, dowry harassment and bride burning are the certain examples of the different kinds of violation of fundamental right of women.

All these evils discussed above on behalf of women are frequently followed in this day-to-day world. As this shows that women or female are considered merely as an object by our society. On one hand we worship goddess or female deity on several occasions and on very next day we forget all rituals or customs and starts continue to again degrade her life.
